## **JOB DESCRIPTION**

TITLE: INSTRUCTOR

**RESPONSIBLE TO:** CHIEF INSTRUCTOR

**LOCATION:** PIONEER CENTRE

**MAIN PURPOSE:** To ensure delivery of activities and facilitate learning

experiences in line with the Organisation's guidelines

for the development of young people who are members of groups served by the Centre.

## **DUTIES AND RESPONSIBILITES**

- 1. To instruct activity sessions and facilitated learning experiences for residential and day visitor groups as qualifications and internal staff training allow.
- 2. In line with the needs of the Centre to carry out the night porter role (10pm to 8am) average 2 nights per ten weeks.
- 3. To assist the Senior Instructor with all the following:
  - To ensure that all operational procedures are carried out to the required safety standards, and that all equipment is installed and maintained to Health and Safety legislation standards.

- Where appropriate, and in conjunction with the Senior Instructor, help train the activity staff to set standards.
- To liaise with group leader(s) at the start of each session to ensure that there is a mutual understanding concerning the activities about to take place.
- Ensuring that the Code of Conduct and handbook is adhered to at all times.
- To establish via the Senior Instructor or the group leaders(s) whether there are
  any particular needs of the guests, e.g. learning difficulties, physical/emotional
  problems, and to ensure that any are handled sensitively during the activities.
- To ensure that the activity team is fully aware of the day's activity program and any other relevant information that may be required.
- When not on activities, make every effort to keep the team usefully occupied with training, session maintenance and development or other scheduled tasks.
- When requested, to assist with either the maintenance or domestic teams when extra help is required and to assist in any other aspect that may arise to ensure the smooth running of the Centre.
- The centre to which you are appointed will be your principal place of work, but from time to time the company may require you to work in another part of the Organisation.
